

DOBOT® FUTURE ME SWEEPSTAKES
OFFICIAL RULES

CONSUMER NOTICE: NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

BY ENTERING THE SWEEPSTAKES, YOU MUST AGREE TO THESE “OFFICIAL RULES,” WHICH CREATE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, SUCH CONTRACT INCLUDES GRANTS OF RIGHTS AND INDEMNITIES TO SPONSOR FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

HOW TO ENTER:

The Dobot Future Me Sweepstakes (the “Sweepstakes”) sponsored by Fifth Third Bank (the “Sponsor”) begins on January 1, 2020 and ends on December 31, 2020 (“Promotion Period”).

During the Promotion Period, log into your Dobot account (or create a free account if you do not already have one) and (1) create a new savings goal titled “Future Me”, (2) set a goal amount for the “Future Me” goal of \$500 or greater, and (3) set the target date for the “Future Me” goal to December 2020 (“Entry”). All Entries must meet each of the three criteria set forth above, and must be open at the time of selection of the Winner to remain eligible Entries.

By submitting an Entry to the Sweepstakes, all entrants are affirming their agreement to the Official Rules. Those who do not follow all of the instructions or abide by these Official Rules or other instructions of Sponsor will be disqualified. All Entries that are in excess of the stated limits, late, incomplete, made outside of the Promotion Period, or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor’s sole and absolute discretion. Sponsor reserves the right to void all Entries made through any robotic, automatic, mechanically programmed or similar entry duplication method and to disqualify any individual using such a method.

Sponsor and affiliated entities are not responsible for lost, misdirected, misplaced, stolen, tampered with, deleted, or invalid Entries. Assurance of delivery of Entries is the sole responsibility of the entrant. Sponsor reserves the right to permanently disqualify from this Sweepstakes any person it believes has violated these Official Rules.

WHO MAY ENTER:

The Sweepstakes is open to all legal U.S. residents who are at least eighteen (18) years old at the time of entry, excluding residents of the states of New York and Florida. Employees of the Sponsor and each of its parents, divisions, affiliates, subsidiaries, advertising agencies or promotional partners associated with this Sweepstakes, and relatives of and those living in the same household of such employees (whether legally related or not) are not eligible to enter or win a prize. For the purpose of this Sweepstakes, relatives are defined as spouse, mother, father,

in-laws, grandmother, grandfather, brother, sister, children and grandchildren. Void where prohibited.

By participating in the Sweepstakes, each entrant represents and warrants that he or she meets these eligibility requirements and has read, accepts and will comply with these Official Rules and each entrant acknowledges that any violation thereof may disqualify entrant from the Sweepstakes.

LIMIT:

Only one (1) Entry per person will be accepted. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The Winner may be required to show proof of being the authorized account holder.

SELECTION OF WINNER:

The winners will be selected at random from the eligible Entries received as of the date of each monthly drawing. The Dobot user who owns the account to which the Entry is associated will be the winner (the “Winner”). Any Entry received before or after the Promotion Period will not be considered.

By submitting an Entry, entrants consent to being contacted by the Sponsor or a representative on its behalf. If the Winner cannot be reached or does not respond to the notification after five (5) calendar days, if he or she is found to be ineligible, or if he or she does not comply with these Official Rules, such potential winner will be disqualified and an alternate winner will be selected at the sole discretion of Sponsor from all remaining Entries, time permitting. Sponsor is not responsible for and shall not be liable for late, lost, damaged, intercepted misdirected, or unsuccessful efforts to notify a Winner.

ODDS:

Odds of winning will depend upon the total number of eligible Entries received during the Promotion Period.

PRIZE:

Five (5) monthly prizes of up to \$100 will be awarded to Winners. The amount of the prize shall be determined by the total amount of money transferred to the Winner’s eligible “Future Me” goal meeting the Entry criteria set forth above at the time of the drawing. If the Winner has not transferred any money to their eligible “Future Me” goal as of the time of the drawing, the prize will be \$5. The prize will be added to the Winner’s Dobot account.

Winner will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the Prize they receive. The total ARV of the Prize awarded in the

Sweepstakes is listed above and the value of any Prize awarded to a Winner may be reported for tax purposes as required by law. The Winner may be required to provide Sponsor with a valid social security number before the Prize will be awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of Winner, or if a minor in the jurisdiction in which he or she resides, in the name of his or her parent or legal guardian, for the actual value of the Prize received. Any unclaimed Prize will be forfeited.

No duplicate prize winners are allowed. Prizes are limited to one per person per calendar year. Prizes are not transferable, nor redeemable for cash unless specifically set forth herein.
